

## The Blockchain Group: New Projects Secured in Recent Months

Puteaux, September 3, 2024 – The Blockchain Group (ISIN Code: FR0011053636, ticker: ALTBG), announces that it has secured new commercial successes over the past few months, further reinforcing its new strategic direction.

The Group has been awarded several significant contracts through its subsidiaries IORGA and TRIMANE.

- Notably, in the Web2 and Web3 sectors, IORGA signed a contract worth up to €800,000 over four years with the Public Interest Group for IT of Management Centers (*Groupement d'Intérêt Public Informatique des Centres de Gestion*). The contract covers the design, development, and maintenance of an application to digitize public accounting for the Management Centers.
- A joint effort between IORGA and TRIMANE led to the signing of a contract with a French multinational group for the migration of Business Intelligence architectures to more agile solutions.
- In May, TRIMANE was selected under a multi-award framework agreement worth up to €2.6 million to support the Data Office of the Paris Île-de-France Regional Chamber of Commerce and Industry in its data-related projects.
- TRIMANE also signed a project to implement a data infrastructure and AI models to match
  the skills in job offers with those described in the ROME/RNCP reference frameworks. This
  project win illustrates the relevance of TRIMANE's strategy, which is to adopt a
  comprehensive approach to AI projects by integrating the essential Data component.

Despite seasonally lower activity during the summer, the past three months also allowed the Group to strengthen the presence of its subsidiaries with several longstanding clients and to open two new client accounts.

"These new commercial successes reflect the relevance of our development strategy and our capacity for innovation, particularly in the field of artificial intelligence," said Lionel RIGAUD, Chief Executive Officer of The Blockchain Group.

This new milestone marks a positive turning point for The Blockchain Group and allows the Company to look to the future with confidence.
