

The Blockchain Group : New commercial successes in autumn 2024

Puteaux, November 27, 2024 – The Blockchain Group (ISIN code: FR0011053636, ticker symbol: ALTBG), announces new commercial successes for its subsidiary TRIMANE and confirms its recovery momentum.

TRIMANE, the data intelligence and artificial intelligence subsidiary of The Blockchain Group, announces the signing of several new contracts.

TRIMANE has won and launched several artificial intelligence projects:

1. A solution for Tisséo with a Big Data architecture recovering real-time data from metro sensors, paving the way for a failure prediction model for optimal service to users;
2. A solution for the retail sector, based on artificial intelligence, which optimizes the assignment of teams to geographical territories on the basis of maximum travel time;
3. A study prior to the experimentation of use cases in artificial intelligence for Paris Ile-de-France Chamber of Commerce and Industry (subsequent contract won as part of the framework agreement recently won to optimize the data strategy of the Paris Ile-de-France Chamber of Commerce and Industry).

Furthermore, 2 new accounts were opened during the period, including a consulting mission for a tool selection study for the implementation of a data platform data platform for the USH (Union Sociale pour l'Habitat).

Lastly, TRIMANE won several major contracts:

1. A 4-year multi-bid framework agreement (3 bidders) has been signed with MIPIH to provide decision-support and Business Intelligence services, worth 2 million euros. MIPIH, France's leader in hospital information systems, supports over 670 healthcare establishments.
2. Another multi-bid framework agreement (3 bidders) was signed with OPCO 2i for assistance with data-related projects, worth 1.2 million euros over 4 years. OPCO 2i supports industrial companies in developing their employees' skills.

The Group specifies that these latest framework agreements will mainly have an impact on results for 2025 and beyond.

These contracts will help solidify the Group's expertise in data and artificial intelligence, while underpinning its long-term development.

“These new opportunities are the fruit of a sharp vision and mark the start of a new phase for our Group. We are determined to capitalize on these projects to strengthen our market position and continue to offer innovative and relevant solutions.” says Lionel RIGAUD, CEO of The Blockchain Group and TRIMANE.
